

### About the NPPC

- Professional Practices Statute passed in 1967
  - Authorizing the creation of the Nebraska Professional Practices Commission
- Nebraska Professional Practices Commission = the governing body for ethical and professional conduct for Nebraska educators.


### **Profession & Ethics**

- Nebraska law recognizes education as a "profession"
  - With all rights, responsibilities and privileges accorded other recognized professions
  - Behaviors/Characteristics of a profession are that the practitioners:
    - Set standards of practice, and
    - Engage in judicial-like process for enforcing those standards
- Responsibilities
  - Educators are expected to follow a Code of Ethics
  - This code outlines appropriate and inappropriate actions
  - Educators are <u>never</u> off the ethical clock (so to speak)

## Title 92, *Nebraska Administrative Code*, Chapter 27, Section 004



- The "Code of Ethics"
- Sets forth five principles to guide ethical and professional practice:
  - Principle I Commitment as a Professional Educator
  - Principle II Commitment to the Student
  - Principle III Commitment to the Public
  - Principle IV Commitment to the Profession
  - Principle V Commitment to Professional Employment Practices



### Hearings & Actions



- Hearings
  - The Commission holds hearings and makes recommendations to the State Board of Education concerning alleged violations of professional ethics and practices.
- Types of Actions
  - Dismissal no action
  - Admonishment a private sanction to certificate holder
  - Reprimand a public sanction criticizing or rebuking certificate holder
  - Suspension public sanction withdrawing/cancelling certificate for a period of time (automatic reinstatement)
  - Revocation public sanction withdrawing or cancelling certificate for a period of time (must apply for reinstatement)
  - If Permanent Revocation, <u>No reinstatement</u>


### Examples & Recent Data



- Least punitive action examples:
  - Private admonishment lying to parents about student absences
  - Public reprimand violating testing protocol
- In the last five years, majority of cases involved some type of:
  - Sexual Misconduct
  - Contract abrogation

### Recent Cases

- NPPC NPPC
- In 2019, thirty-four (34) petitions were filed most petitions ever filed in a single year!
- For 2021, a total of eleven petitions have been filed to date
- Five of those petitions have been heard by the Commission this year
- Reasons for these petitions:
  - 1 Contract abrogation
  - 1 Possession of child pornography
  - 1 Violate school policy
  - 1 Inappropriate contact and communication
  - 1 Disturbing the peace, drive without interlock device
  - 2 Unprofessional conduct
  - 1 Make terroristic threats
  - 1 Reinstatement
  - 2 Inappropriate relationship with student
